Nor Cal SAAC Friends of the Club

The Friends of the Club list is reviewed Semi-annually, during the months of January/July, by a subcommittee made up of 3 members from the Board of Directors. (BOD) This committee will review/investigate as needed and then present its findings to the BOD. Additions/subtractions to the list will, generally, be made during those months.

Friends of the Club (FOC) – Defined:

“To be a Friend of the Club is to provide the membership of Nor Cal SAAC with a unique automotive related service/product that is unavailable elsewhere or a standard automotive related service/product at a discounted rate.”

Requirements to be a FOC:

- FOC must be members in good standing with Nor Cal. Memberships must be kept current. We also ask for a **\$102** fee for the advertising in the club newsletter and website for a total cost of **\$150** (\$102+48).
- Generally, a business seeking FOC status would need to have existed (“Doors open”, internet included) for one year. The BOD would then need positive feedback from 3 or more Club members to place this business up for the bi-annual review.
- Failure to follow the guidelines of a FOC could cause a business to be removed from the FOC list; in the club’s newsletter, Driven, and the Web site.
- Existing FOC’s that go out of business or have a change of ownership will be removed from the list. New owners may seek new FOC status during the Bi-annual reviews.
- Meeting the FOC defined requirements may also take the form of: 1) Providing automotive related services/products that could be raffled off during general membership meetings and or track events. 2) Providing informational lectures on automotive related products/services during general membership meetings and or track events.
- At no time, will the BOD/OTEC/or the Club Membership be drawn into any disputes between a member(s) and a FOC.
- A list of all the FOC will be maintained on the Nor Cal Website. It is the responsibility of FOC to make sure that the information provided to the Webmaster and that information which is placed on the website is current and correct.
- Due to the limited space in the club newsletter, Driven, not all current FOC may be able to have their business information appear in every edition of it.
- FOC information in Driven will be limited to: Company name, contact name, address, phone number, and E-mail/web site addresses.
- The Club will not be held responsible for any information on the Club website or printed in Driven

- If FOC's desire advertisement space in Driven, it will only be made available in the form of a one (1) 8.5 x 11 page insert. Both sides may be used, or a FOC may share one side with another FOC. The cost and logistics of producing the advertising insert will be born by the FOC's and not the Editor. The cost of inserting the advertisement into Driven and its added delivery costs will be calculated by the Editor and born by the FOC.
- Advertisement space in the Driven newsletter is not available.
- Inserts for FOC's will be limited to once every twelve (12) months. It will be made available on a first come, first served basis. Contact will be made with the Editor, **via E-mail only.**
- Inserts for club business (i.e.: club special events or track events) shall take priority over all FOC inserts. A maximum of two (2) inserts will be allowed per Driven.
- **The Driven Editor has the final say in all insert matters.**
- **Nor Cal SAAC reserves the right to refuse a business from becoming a FOC and/or remove an existing FOC from our lists.**
